## AKC OC/RC Match--Obedience and Rally.

**This will be a rent-a-ring style match.**

Your entry gives you 10 minutes in the ring to use as you choose. A full set of jumps will be available. No harsh corrections or e-collars will be allowed. Toys are welcome as training aids. Out of consideration for the exhibitors using the rings for actual trials the following day, please, no tossing or spitting food in the ring. A Rally ring with nested Excellent/Advanced/Novice courses will be available from 1:00 pm to 2:00 pm only. After 2:00 pm the Rally ring will be used for Beginner Novice and Novice run-throughs.

Kern County Fairgrounds

(same site/rings as the Kern County Kennel Club All-Breed Shows/Trials on March 29 & 30)

**Day of match registration begins at 12:00 pm. and closes at 2:00 p.m. or whenever the entry limit is reached, whichever comes first.**

**Match will begin at 1:00 pm. Limit of 40 runs total.**

**\*\*Due to entry limits, Pre-entry is strongly encouraged\*\***
